**STUDENT REGISTRATION AFFIDAVIT, ACKNOWLEDGMENT AND AUTHORIZATION**

That by signing this Affidavit I/We do hereby authorize the Fort Cherry School District to report the fact that said student is residing with me/us in the Fort Cherry School District to the proper State and Federal authorities, including but not limited to, the Internal Revenue Service and Social Security Administration.

I/we also acknowledge that if this Affidavit is found to be false, that I/We will be responsible to pay the tuition established by the Board of School Directors of the Fort Cherry School District for the period said student was in attendance in the Fort Cherry School District as well as any and all costs and attorneys fees necessary to establish the true residence of the student and to collect the tuition due.
7. That by signing this Affidavit I/we do hereby authorize the Fort Cherry School District to have access to any and all of my/our records which might be related to the establishment of residency in relation to said student.

**Section 1304-A of the Pennsylvania Public School Code, 24 P.S. § 13-1304-A**, provides that "Prior to admission to any school entity, the parent, guardian or other person having control or charge of a student shall, upon registration, provide a sworn statement or affirmation stating whether the pupil was previously suspended or expelled from any public or private school of this Commonwealth or any other state for an act or offense involving weapons, alcohol or drugs, or for the willful infliction of injury to another person or for any act of violence committed on school property."
