Athletics:

Track & Field - Boys are currently 5-0 and Girls are currently 5-0 in the section. One last section tri – meet vs. South Park and Burgettstown on 4/17/24 at South Park. The section title is at stake for both boys and girls. Both the boys and girls team won the Chartiers Houston invitational. Ava Menzies won the mvp award. After the last section meet on 4/17/23, three invitational meets remain before the team playoffs the first week of May and individual WPIAL championship in mid May.

Baseball - The baseball team is currently 5-1 overall and ranked 5th in the WPIAL.

Softball - The softball team is currently 0 – 6 overall.

Basketball – Raney Staub and Derek Errett were both selected to play in the Roundball Classic at Geneva College Memorial day weekend. Both cagers achieved the 1000 point mark on the season. The boys basketball team ended up finishing 3rd in the WPIAL and made the state semifinals. They finished ranked #4 in the state in AA basketball. With their 23-7 overall record they lost to Aliquippa in both the WPIAL semifinals and PIAA semifinals.

Matt Seig and Lou Ryan will be recognized for achieving 1st team all state in Football.

SPECIAL EDUCATION

Elementary Life Skills (currently 5 students): Consultation with Watson Institute is ongoing. Monthly team meetings are being held with the classroom staff, related service providers, and administration to provide a forum for discussion. There is continued progress with all students.

Monitoring: The District received its findings from Cyclical Monitoring for Special Education. As expected, the District has 2 areas for improvement: Least Restrictive Environment and Assessment Participation. PDE is accepting the assessment participation plan previously submitted to PDE as corrective action for that area. Dr. Lauver and PDE will discuss what corrective action will be made for

Least Restrictive Environment. As mentioned in last month's report, we have reached the state average by system changes made this year. PDE and PaTTAN will setup a meeting with Dr. Lauver to follow up.

Paraprofessionals: Due to 2 resignations, we are now hiring for 2 vacancies.

ARC of PA: Dr. Lauver will be hosting ARC of PA for walkthroughs in April to start our partnership.

Teaching Position: The District has one open special education teaching position. We have over 20 qualified applicants, so we hope to have a recommended candidate for April's board meeting.

GUIDANCE

Scheduling: Scheduling feedback information for 24-25 distributed to Board members.

GIFTED

Acceleration: Dr. Lauver met with both Mrs. Drummond and Mrs. Krajci to go over the new K-BIT testing edition and administration protocols with our Gifted Matrix. Additionally, Mrs. Eiler is leading a new Child Find process for potentially-gifted students in grades 4–6 at FCEC. These protocols form the foundation for a new Gifted Procedures manual that will guide our decision making processes moving forward.

FEDERAL PROGRAMS

SPECIAL EDUCATION

Elementary Life Skills (currently 5 students): Consultation with Watson Institute is ongoing. Monthly team meetings are being held with the classroom staff, related service providers, and administration to provide a forum for discussion. There is continued progress with all students.

Monitoring: Dr. Lauver met with PaTTAN and PDE regarding the findings from monitoring. The state has accepted the District's assessment participation plan as part of corrective action. The state is pleased with the progress toward Least Restrictive Environment targets, and it is expected that PDE will close this area out after the Child Count in December 2024. Small file items are being corrected by staff, and they will be submitted well before the 365 day deadline.

Paraprofessionals: Due to 2 resignations, we are now hiring for 2 vacancies. Interviews are scheduled for 4/26.

ARC of PA: Dr. Lauver hosted walkthroughs with ARC of PA to determine current levels of performance in Co-Teaching. This will form the foundation for training for staff in grades 4–8 during the August inservice.

Teaching Position: The District has identified a qualified and experienced candidate for the special education vacancy. Due to her current contractual status, she will not be able to begin until the first day of the 2024–25 school year.

State Funding Applications, Mandates and Updates:

PCCD Awarded Fort Cherry the Meritorious MH/Safety Grant for \$30,000.

The Fort Cherry School District is awaiting to hear if the PCCD grants for MH and the Competitive Safety Grant will be funded.
