Building and Grounds

Due to the installation of the new gym bleachers, we ended up hosting more games than usual during the second half of the fall season. We also held an open house at the elementary school and multiple evening events at the high school. Additionally, we have begun the process of cleaning up leaves outside while keeping up with the grass.

We hosted three additional high school games, multiple JV and junior high games, and the Little Rangers had their last few games at the stadium as well. These events are labor-intensive, involving both field

and stadium maintenance. We have also spent time working on the junior high softball field. Inside the schools, time has been spent on various maintenance tasks.

Over the past few weeks, the maintenance staff worked to build new raised garden beds, which are now in place between the two schools on the island. We have also switched the chiller to the boilers as the weather turns colder, and staff have been addressing HVAC issues in both schools—specifically in room 201 at the elementary school, where we worked to remove nests built inside the unit. Last week, our battery backup failed on the boiler system. Although we did not lose power, the system shut down because the power runs through the backup, and the battery had aged out. We are now back up and operational. We have also begun the process of replacing a pump inside the elevator shaft at the EC, which was discovered to have stopped working during a semi-annual inspection.

We have also initiated evening inspections of the cleaning staff. Monthly staff meetings have been held and will continue. We welcomed two new staff members: a four-hour cleaner and a new evening floater. Both have shown great care and attention to their roles and are expected to grow into valuable team members.

My department will continue to experience staff turnover in the coming months as we replace employees who have taken new roles within the district and prepare for impending retirements. I am excited to see new faces throughout the buildings as we work to change the culture of the department to better serve all stakeholders at Fort Cherry.
